## **1. Introduction**

## **6. Data Retention**

## 7. Your Rights

You have the following rights regarding your personal data:

- **Right to Access:** You can request access to the personal data we hold about you.
- **Right to Rectification:** You can request correction of any inaccurate or incomplete data.
- **Right to Erasure:** You can request deletion of your personal data, subject to certain conditions.
- **Right to Restrict Processing:** You can request restriction of the processing of your personal data in certain circumstances.
- **Right to Data Portability:** You can request to receive your personal data in a structured, commonly used, and machine-readable format and have the right to transmit that data to another controller.
- **Right to Object:** You can object to the processing of your personal data in certain circumstances.
- **Right to Withdraw Consent:** You can withdraw your consent at any time, without affecting the lawfulness of processing based on consent before its withdrawal.

## 8. Data Security

We implement appropriate technical and organizational measures to protect your personal data against accidental or unlawful destruction, loss, alteration, unauthorized disclosure, or access.

## 9. Sharing of Personal Data

Only authorized personnel of Hypefy World j.d.o.o. and data processing executors who maintain our website have access to your data. They process data only in accordance with our instructions and are subject to a duty of confidentiality.
